Stock Management

- Receive inward goods – loading/unloading of trucks using reach truck and entering the details into the ERP system.
- Daily picking of product required for delivery or return of consumables to and from all departments as per departmental needs.
- Transfer and receipt raw materials and finished goods for dispatch and delivery to and from various departments across DEC.
- Ensure the warehouse department and associated areas are maintained to the required standard, whilst ensuring associated documentation is completed.
- Ensure sufficient levels of consumable goods related to manufacturing, café and sundry items are maintained.
- Assist the logistics department with any administration, despatch tasks, picking and packing shipments, and loading trucks or containers.
- Ensure own currency in all standard operating procedures for the tasks being performed and follow the progression plan as outlined separately.
- Any other responsibilities or tasks as instructed that is in line with the role or ability.
